Open to all active members except administrators and supervisors. Specific geographic areas and terms will be included in the Kansas NEA Fall Edition of KS EDTALK. Nomination forms must be received by the Kansas NEA Office of the President by 5 PM, December 1, 2023.

**KNEA RETIRED**

Open to any KNEA Retired member who is not employed by a public school district, public college, or other public educational institution, which would require them to contribute to a public pension and thereby make them eligible for active membership. This nomination form must be received by the Kansas NEA Office of the President by 5 PM, December 1, 2023.

**ADMINISTRATOR/SUPERVISOR (CATEGORY 2)**

NEA Bylaw 12-1(e) defines Category 2 positions as NEA Active members in supervisory roles. Nomination forms must be received by the Kansas NEA Office of the President by 5 PM, December 1, 2023.

**CLUSTER**

Open to all active members except administrators and supervisors in local affiliates with less than 76 members. If you are unsure of the size of your local, feel free to check this box. The Office of the President will verify the eligibility of all nominations. **Nomination forms for cluster delegates must be received by the Kansas NEA Office of the President by 5 PM, February 29, 2024.**
